1 For the reasons set forth on the record at the hearing held on January 5, 2010, the Court
 2 granted the motions by Certain Direct Lenders to withdraw the reference for the entirety of the
 3 above-captioned chapter 11 cases. As a result, and for the reasons also stated on the record at that
 4 hearing, cause exists under 11 U.S.C § 362(a) to GRANT Certain Direct Lenders' Motion for
 5 Limited Relief from Automatic Stay, filed December 9, 2009 [Doc. #113],


